## INVITATION TO BID

### ACQUISITION OF SECURITY SERVICES

- The Southern Leyte State University Main Campus intends to apply the sum of **TWO MILLION SEVEN HUNDRED FIFTEEN THOUSAND PESOS only (₱2,715,000.00)** being the Approved Budget for the Contract (ABC) through the following source of funds:

to payments under the contract for the **Acquisition of Security Services** for the period of one (1) year to commence from the date of receipt of Notice to Proceed (NTP). Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The Southern Leyte State University now invites bids for the above Procurement Project. Delivery of the Goods is required **within one (1) year** as specified in the Schedule of Requirements. Bidders should have completed, **within five (5) years** prior to the date of submission and receipt of bids, a contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. No. 5183.

- Interested bidders may obtain further information from Southern Leyte State University Main Campus and inspect the Bidding Documents at the address given below from 8:00am-5:00pm.
- A complete set of Bidding Documents may be acquired by interested Bidders starting on **12 May 2021** from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of **THREE THOUSAND PESOS ONLY (₱3,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- The Southern Leyte State University will hold a Pre-Bid Conference on **20 May 2021, 3:30 P.M.** at the Plenary Hall, USSC Bldg., SLSU Main Campus, Sogod, Southern Leyte which shall be open to all interested parties. To reduce the risks and hazards of community transmission of COVID 19, the BAC shall conduct meetings through videoconferencing until further notice, or until such time that
