INVITATION TO BID  
SUPPLY, DELIVERY & INSTALLATION OF ICT EQUIPMENT & OTHER PERIPHERALS

1. The Southern Leyte State University-Maasin City Campus, through the following funding source:

Internally Generated Fund 1,085,000.00  
Regular Agency Fund 1,300,000.00  
TOTAL ₱2,385,000.00

intends to apply the sum of TWO MILLION THREE HUNDRED EIGHTY-FIVE THOUSAND PESOS only (₱2,385,000.00) being the proposed Approved Budget for the Contract (ABC) to payments under the contract for the project: Supply, Delivery & Installation of ICT Equipment & Other Peripherals under Project/Contract No. PB 2024-G&S-03. The period for the performance of the obligations under the Contract shall not go beyond the validity of the appropriation for the Project. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Southern Leyte State University-Maasin City Campus now invites bids for the above-entitled Procurement Project. Delivery of the Goods shall be in accordance with Section VI (Schedule of Requirements), and Section VII (Technical Specifications) of the Bidding Documents reckoned upon receipt of the Notice to Proceed. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders. Bidders

should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Southern Leyte State University-Maasin City Campus BAC Secretariat and through the e-mail address given below and inspect the Bidding Documents posted on the SLSU website and PhilGEPS website.

5. A complete set of Bidding Documents, in digital copy, may be acquired by interested Bidders starting on September 5, 2024, from the address below and upon payment of the applicable fee in the amount of Five Thousand Pesos Only (5,000.00) for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents either in cash or through SLSU LBP IGF Account No. 0942-1212-02 (Maasin Branch) not later than the deadline for the submission of bids.

Bidders shall present its confirmation receipt to the BAC Secretariat in person, by facsimile, or through electronic means, which shall be used as proof of payment for the bidding documents fee.

6. The Southern Leyte State University - Maasin City Campus will hold a hybrid Pre-bid Conference on September 13, 2024 8:30 in the morning at the Campus Director's Conference Room, SLSU Maasin City Campus - Maasin City, Southern Leyte which shall be open to all interested parties. The link will be provided at a later date through the BAC Secretariat.

7. Bids must be submitted in sealed envelopes with the title of the procurement project name, name of Bidder, address of the Bidder, and contact details of the Bidder, duly received by the BAC Secretariat through manual submission at the office address indicated below on or before September 25, 2024 at 2:00 in the afternoon. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on September 25, 2024 at 2:15 in the afternoon at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The Southern Leyte State University - Maasin City Campus reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
