



BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AS A RESULT OF POST- QUALIFICATION AND RECOMMENDING AWARD FOR THE PROVISION OF CATERING SERVICES FOR THE PROJECT “CULTIVATING FINANCIAL LITERACY FOR MARGINALIZED FARMERS AND FISHERFOLKS ECONOMIC GROWTH: ADVANCING MONETARY UNDERSTANDING AND MANAGEMENT (AMUMA)” LOT 5 & 6 (NEGOTIATED PROCUREMENT – TWO-FAILED BIDDINGS)

RESOLUTION NO. 42, S. 2024

WHEREAS, the Bids and Awards Committee (BAC) was created to ensure transparency in the procurement process and in the implementation of procurement contracts, with the end view of guaranteeing the contracts are awarded pursuant to the provisions of Republic Act 9184 and its Implementing Rules and Regulations, and that all procurement are conducted strictly according to specifications;

WHEREAS, in accordance with pertinent provisions of RA 9184, the BAC published on 13 September 2024 in the PhilGEPS, SLSU website and BAC Bulletin board the Invitation to Bid (IB) for the **Provision Of Catering Services For The Project “Cultivating Financial Literacy For Marginalized Farmers And Fisherfolks Economic Growth: Advancing Monetary Understanding And Management (AMUMA)” (Negotiated Procurement – Two-Failed Biddings)** consisting of **Lot 5 & 6** under Project No. **PB 2024-G&S-09** with a total Approved Budget for the Contract (ABC) amounting to **Seven Hundred Forty-Nine Thousand Eight Hundred and Fifty Pesos only (₱449,800.00)**;

WHEREAS, in furtherance with the provisions of the Revised RA 9184, representatives from the Commission on Audit (COA) as well as observers from private sector and non-government organization, were invited to observe and witness the conduct of the Pre – Bid Conference, Submission and Opening of Bids, Evaluation of Bids, and Post-Qualification as scheduled;

WHEREAS, on 03 October 2024, BAC passed Resolution No. 41, s. 2024 declaring the Derf’s Grill and Restaurant as the Single Calculated Bid (SCB).

WHEREAS, upon careful examination, validation and verification of all technical and financial proposals submitted by Derf’s Grill and Restaurant, BAC found their bid offers to be compliant with all the legal, technical and financial requirements, and declared as the Single Calculated and Responsive Bid (SCRB) for **Lot 5 & 6** with a **total contract amount of Four Hundred Ninety-Six Thousand Four Hundred and Sixty-Eight Pesos only (₱496,468.00)**



NOW, THEREFORE, with the foregoing premises considered, the undersigned members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To declare the Derf's Grill and Restaurant with the Single Calculated and Responsive Bid for **Lot 5 & 6**;
2. To recommend to the SLSU Board of Regents as the University 's Head of Procuring Entity (HoPE) to award the contract to the abovementioned supplier.
