General Conditions of the Contract:

- 1 All entries must be typewritten/handwritten.
- 2 Bidders shall provide correct and accurate information required in this form.
- Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- 4 Quotations exceeding the Approved Budget for the Contract shall be rejected.
- ⁵ In case of tie among bidders, SLSU shall adopt and employ "draw lots" as the tiebreaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.
- 6 Award of contract shall be made in accordance with the Implementing Rules and Regulations of RA 9184 and RA 12009, whichever is applicable.
- 7 All bidders shall be required to include the cost of all taxes, such as, but not limited to, value added tax (VAT), income tax, local taxes, and other fiscal levies and duties which shall be itemized in the bid form and reflected in the detailed estimates. Such bids, including said taxes, shall be the basis for bid evaluation and comparison. Moreover, applicable custom duties, as well as other costs of acquisition such as delivery/freight, insurance, and bank charges, must be incorporated in the bid.
- Liquidated damages equivalent to one-tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. The Southern Leyte State University may terminate the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
- 9 Delivery period on specified dates.
- Warranty shall be a period of SIX (6) months for supplies and materials, ONE (1) Year for the equipment, from the date of acceptance by Southern Leyte State University.
- 11 Price validity shall be a period of THIRTY (30) calendar days.
- Valid PHILGEPS registration certificates and Mayor's/Business Permit shall be attached upon submission of the quotation.
- 13 **Notarized Omnibus Sworn Statement** shall be attached upon submission of quotation for ABC amounting to Fifty Thousand Pesos (₱50,000.00) and above, in accordance to Annex "H" Appendix A of RA 9184
- 14 Income/Business Tax Return shall be attached upon submission of quotation for ABC amounting to Five Hundred Thousand Pesos (₱500,000.00) and above, in accordance to Annex "H" Appendix A of RA 9184
