



Invitation to Bid for Painting of Administration Building – Re-bidding

- 1) The **Southern Leyte State University - Sogod Campus**, through the **Internally Generated Fund** intends to apply the sum of **One Million One Hundred Twenty-Six Thousand Seven Hundred Eighty-Seven Pesos and 92/100 only (P1,126,787.92)** being the Approved Budget for the Contract (ABC) to payments under the contract for Painting of Administration Building. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The **Southern Leyte State University - Sogod Campus** now invites bids for **Painting of Administration Building – Re-bidding** of SLSU Main Campus, San Roque Sogod Southern Leyte. Completion of the Works requires **90 calendar days**. Bidders should have completed, within **5 years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4) Interested bidders may obtain further information from **Southern Leyte State University - Sogod Campus** and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Monday to Friday.
- 5) A complete set of Bidding Documents may be acquired by interested bidders on **October 31, 2025**, from the address below.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents either in cash or through **SLSU SOGOD CAMP LBP Current Account No. 3322-1003-95** amounting to **Five Thousand Pesos (P5,000.00)** not later than the deadline for the submission of bids. Bidders shall present their confirmation receipt to the BAC Secretariat in person, or through electronic means, which shall be used as proof of payment for the bidding documents fee. Participating bidders on the initial bidding are no longer required to pay the bidding documents.

- 6) The **Southern Leyte State University - Sogod Campus** will hold a Pre-Bid Conference on **November 07, 2025 at 9:30 AM** in Discussion Room, New Library Building SLSU Main Campus, San Roque Sogod Southern Leyte and/or through video conferencing via Microsoft Teams Meeting ID: 418 840 339 550 9 ; Passcode: mT2Mp78a, which shall be open to prospective bidders.

- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the address indicated below on or before **November 19, 2025 at 9:00 in the morning**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9) Bid opening shall be on **November 19, 2025 at 9:30 in the morning** in Discussion Room, New Library Building SLSU Main Campus, San Roque Sogod Southern Leyte. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

- 11) The **Southern Leyte State University - Sogod Campus** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
