### CONTRACT FOR

### SUPPLY, DELIVERY, AND INSTALLATION OF ICT EQUIPMENT AND ACCESSORIES – NEGOTIATED PROCUREMENT

THIS CONTRACT executed on the JAN 16 2026 day of \_\_\_\_\_ 2026 between:

**SOUTHERN LEYTE STATE UNIVERSITY**, a government agency of the Republic of the Philippines, hereinafter called “the Entity”;

-and-

**LEYTE PAPERWORLD**, a company duly organized and existing under the laws of Tacloban City, Leyte, Philippines, with principal office at **168 MH Del Pilar St. Tacloban City, Leyte**, hereinafter called “the Supplier”.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery, and Installation of ICT Equipment and Accessories – Negotiated Procurement** with Project ID No. **PB 2025-G&S-16**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **Two Million Seven Hundred Eighty-Eight Thousand Four Hundred Ninety-Nine Pesos only (₱2,788,499.00)**, hereinafter referred to as the “Contract Price.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

- 1) Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
- 2) The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall be deemed to form and be read and construed as integral part of this Contract, viz:
  - a) Philippine Bidding Documents (PBD);
    - i. Invitation to Bid;
    - ii. Instruction to Bidders;
    - iii. Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
    - iv. Bid Data Sheet;
    - v. Schedule of Requirements;

  - ix. Other contract documents that may be required by existing laws and/or the Entity.
- b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - c) Performance Security;
  - d) Notice of Award of Contract; and the Bidder's Conforme thereto; and
  - e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
- 3) In consideration of the Contract Price of **Two Million Seven Hundred Eighty-Eight Thousand Four Hundred Ninety-Nine Pesos only (₱2,788,499.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the Supplier agrees to deliver and perform the items and related services for the **Supply, Delivery, and Installation of ICT Equipment and Accessories – Negotiated Procurement** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
  - 4) The **SOUTHERN LEYTE STATE UNIVERSITY** agrees to pay the above-mentioned sum to the Supplier in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
  - 5) Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act (RA) No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
  - 6) **Grounds for Termination.** The parties herein may terminate the whole or any part of the Contract in accordance with the provisions of the Section 71.4.1 (b) of Implementing Rules and Regulations of RA 12009.
  - 7) **Venue of Action.** Venue of all actions arising from this Agreement shall be brought exclusively to the jurisdiction of the appropriate Court of Sogod, Southern Leyte, Philippines.
