Description:**INVITATION TO BID****FOR SUPPLY, DELIVERY, AND INSTALLATION OF MULTI-PURPOSE COURT SOUND SYSTEM**

1) The Southern Leyte State University – Main Campus, through the Internally Generated Fund intends to apply the sum of One Million Three Hundred Twenty-Six Thousand Two Hundred Twenty-Five and 74/100 pesos only (₱1,326,225.74) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, Delivery, and Installation of Multi-Purpose Court Sound System. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The Southern Leyte State University – Main Campus now invites bids for Supply, Delivery, and Installation of Multi-Purpose Court Sound System. Delivery of the Goods is required 45 days. Bidders should have completed, at least 5 years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4) Interested Bidders may obtain further information from Southern Leyte State University – Main Campus and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

5) A complete set of Bidding Documents may be acquired by interested Bidders on February 13, 2026 from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (₱5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents either in cash or through SLSU SOGOD CAMP LBP Current Account No. 3322-1003-95 not later than the submission of their bids.

6) The Southern Leyte State University – Main Campus will hold a Pre-Bid Conference on February 27, 2026 at 01:30 in the afternoon at Conference Room, Quality Assurance Office SLSU Sogod Campus and/or through video conferencing via Microsoft Teams Link <https://teams.microsoft.com/meet/44437312266374?p=KO2U8SR7sCT6dYBi0U>, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below on or before March 11, 2026 at 9:00 in the morning. Late bids shall not be accepted.

8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9) Bid opening shall be on March 11, 2026 at 1:30 in the afternoon at Conference Room, Quality Assurance Office SLSU Sogod Campus and/or via Microsoft Teams Link <https://teams.microsoft.com/meet/44468042419560?p=1GNGjyqpv9u254r0gm>. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

10) The Southern Leyte State University – Main Campus reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 704 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
