A RESOLUTION APPROVING THE FREEDOM OF INFORMATION MANUAL

Whereas, Executive Order No. 2, s. 2016, Operationalizing in the Executive Branch the people's constitutional right to information and the state policies to full public disclosure and transparency in the public service and providing guidelines therefor;

Whereas, the freedom of Information Manual (FOI) will provide the process by which the Southern Leyte State University deals with requests for information under Executive Order No. 2, s.2016;

Whereas, the University President presented the proposal for endorsement by the University Administrative Council and the Board of Regents -Research and Administration Committee;


Whereas, the University Administrative Council in its meeting on August 31, 2017 favorably endorsed the proposal for approval by the Board of Regents;


Whereas, the Board of Regents -Research and Administration Committee (BOR-RAC) reviewed the details of the proposal during its meeting on September 30, 2017 and recommended board approval;


Wherefore, finding the BOR-RAC's recommendation acceptable, the Governing Board agreed to approve the proposal;

Resolved, as it is hereby resolved, that the Board of Regents of Southern Leyte State University approves the SLSU Freedom of Information Manual.






